Timeline and Course Requirements

Our 60-credit program is designed to offer students a solid grounding in the theoretical frameworks of counseling through hands-on experience and in-person instruction.

Our Counseling Graduate program fulfills the academic requirements for you to obtain your LPC. Our part time option spreads those hours over 3+ years, providing you the flexibility you need to live a balanced life while achieving your professional goals.

An initial practicum (100 hours) and a final internship (600 hours) are required in both tracks. You may be able to use your current job toward internship credit.

Faculty

Students learn from dedicated faculty who have real-world clinical experience and are active in professional counseling associations. Our faculty includes strong mentors who are invested in helping students achieve their educational goals while balancing challenging work/life demands. LICENSURE

Our program meets the academic requirements for licensure as a Licensed Professional Counselor (LPC) in Virginia under the Department of Health Professions. The school counseling track also follows the Commonwealth of Virginia Department of Education licensure regulations for school counselors.

CSAC CREDENTIAL

Program coursework satisfies all didactic training requirements for the Virginia Certified Substance Abuse Counselor (CSAC) credential.

ADMISSION REQUIREMENTS

- ✓ **Official bachelor's degree transcripts** from an accredited college or university and all transcripts for subsequent coursework
- ✓ A minimum overall undergraduate **GPA of 2.75** on a 4.0 scale

- ✓ **Two letters of recommendation**
- ✓ **Resume**
- ✓ **Essay of 250 to 500 words:** Why do you want to be a counselor and why will this program would be a good fit for you?
- ✓ **Interview**
- ✓ **CastleBranch Criminal background check** required after admission to accept offer
- ✓ **\$40 application fee**
