GREETINGS FROM Foundation President Robert S. Wertz, Jr. and CEO, Burt Hazelwood

Thank you for your support of the Longwood University Foundation. As we write this message, U.S. News and World Report issued its annual best colleges rankings validating the wise investment in a Longwood education, with Longwood moving up to #5 in the Top Public Universities in the South category. Since its establishment in 1959, the Longwood University Foundation has assisted in stewarding private gifts to support students, faculty, and programs for Longwood. 2021 was another exceptional year for the Longwood University Foundation as we continued to operate through the pandemic. Dedicated staff and devoted volunteer Board members worked on a number of strategic initiatives positioning the Foundation for growth.

We thank immediate past President, Joseph C. McPhail, III, for his focus on strategic planning and risk management. The Foundation's three major standing committees: Stewardship and Student Success, Finance and Investment, and Governance have in place a process to regularly review risks to the Foundation, its assets, and its operations, and meet regularly to accomplish our mission of stewarding scholarship and programmatic funding to benefit Longwood according to donor wishes. The Foundation works to strengthen its partnership with the University by maximizing scholarship dollars, through its collaboration with Advancement, Admissions, Finance, and the Registrar, and accelerating its distribution of programmatic support funds to the University.

While market forces of late haven't been as favorable, the Foundation ended 2021 up \$14.7 million, with \$116 million in total assets. For academic year 21-22, the scholarship and programmatic support were \$2.23 million and \$733,000, respectively. 704 students and multiple Longwood programs benefited from the contributions of generous donors made over the last 60 years.

You too can help these efforts. A description of Longwood's Giving Societies as well as the variety of ways to give to Longwood is contained in this year's report. We couldn't do this important and rewarding work without our generous donors, exceptional staff, and dedicated Board members and University partners. On behalf of the Foundation, thank you for your investment in Longwood and its students.

Its primary role is to manage the endowed investments, seeking to continue growth, while administering the award and distribution of scholarships and program funding according to the stated intent of donors.

Timeline of an Endowed Gift

Donors can elect to give an operating gift above and beyond their endowment pledge, allowing the endowment to be awarded prior to maturity thus providing an immediate impact.

01

A Longwood University Gift Officer works with a potential Donor to identify their passion and assist them in making the decision to invest in Longwood by establishing an endowed scholarship or program gift through the Longwood University Foundation.

03

The Donor fulfills the pledge established in the Statement of Intent in a lump sum or over a period of 1 to 5 years to reach the minimum endowment level.



The Donor and Gift Officer finalize details about the endowment, which results in the Endowment Agreement and Statement of Intent. Important details include determining the name of the endowment, the criteria for awarding, the type of gift establishing the endowment, and the pledge schedule to fund the endowment. Endowments can be established through the gift of cash, investments, retirement plans, life insurance, or bequests. 04

Once the Donor fulfills the minimum endowment requirement, the endowment enters a maturation period. This maturation period allows the endowment to grow prior to its first distribution.

The Donor's endowed gift benefits Longwood University for generations to come!



At the conclusion of the maturation period, the endowment is ready for annual distribution of awards based on a percentage set by the Longwood University Foundation's Board of Directors.

To smooth out market volatility, the distribution is calculated based on a prescribed quarterly average.

Each year the Longwood University Foundation keeps Donors updated with a report outlining endowment performance and any scholarship recipient information.



Arlene Cundiff '68 shares how she has been able to give back to Longwood, the alma mater that developed her confidence and teaching skills.

In the mid-60's, Arlene Cundiff dropped out of college after two years at a junior college. Arlene began working as a secretary for Burlington Industries and, after a few years, was offered a promotion as the secretary for the plant manager. Excited by the offer and the potential for growth at the company, Arlene inquired about what would be next after that position. When she learned that the position would be the end of her advancement opportunities, she decided to go back to school. "Longwood was, for me, the perfect solution," Arlene states of her decision to enroll in the teaching program at Longwood. Arlene was welcomed as an older student by Longwood, an all-girls college at the time, which instilled in her a level of confidence that she has carried with her throughout her entire lifetime. Arlene enjoyed the smaller classes and the welcoming staff and faculty. Longwood offered her the camaraderie and immediate feeling of "home." She describes it simply, "It was my home and that was my family."

Arlene graduated in 1968 and was able to secure a good teaching job due to Longwood's "phenomenal reputation." Arlene remained in the field of education throughout her career, eventually retiring from Virginia's Department

of Education. Although she regularly contributed to Longwood through the years, she remembers doubting she would be in a position to establish a scholarship; however, Longwood's Gift Officers were able to show her how she could donate over a period of time. In addition to giving to the scholarship, Arlene convinced all her friends, her sisters, and anybody who was wanting to buy her a birthday present or a Christmas gift to send a check to Longwood for her scholarship.

Arlene hopes her scholarship will provide opportunities to Longwood students who might feel like limited opportunities exist for them. While at Longwood, Arlene played intercollegiate sports and remembers the camaraderie of riding the Longwood bus with her brown bag lunch packed by the dining hall and how the opportunity expanded her world. She hopes that she can make an impact in somebody's life. Since 2018 the Arlene D. Cundiff Scholarship has provided scholarships to female student athletes from Virginia. Having met her scholarship recipients, Arlene says, "It's just the ability of that scholarship being able to make a little bit of difference in somebody's life and being able to help somebody get to the point they can achieve their goals - it's a good feeling."

When asked about the importance of giving and supporting opportunities for Longwood students, Arlene says, "I think giving back is so important ... I love Longwood. Longwood was probably the best thing in my life. It gave me focus. It gave me a family. It gave me a history. All the memories and all of the good times and all of the good people. I made a lot of good friends along the way and I'm ready to go back to Longwood anytime they need help. It's a good place to be."

Bequest

Designate Longwood as the beneficiary of your asset by will, trust or beneficiary designation form.

IRA Rollover

Congress has enacted a permanent IRA charitable rollover. As a result you can make an IRA rollover gift this year and in future years.

Required Minimum Distribution (RMD)

Consider gifting part or all of your RMD if you are at least 72 or older. Utilizing the IRA rollover may also satisfy your required RMD for the year.

Beneficiary Designation Gifts

Designate Longwood as a beneficiary of a retirement, investment or bank account or your life insurance policy.

Charitable Gift Annuity

Transfer your cash or appreciated property to Longwood in exchange for our promise to pay you fixed payments (with rates based on your age) for the rest of your life.

Donor Advised Funds

Create a DAF and make charitable gift recommendations during your lifetime. When you pass away, your children can carry on your legacy of giving. Longwood has given me a wonderful support system of professors, mentors, and friends who encourage me to learn and grow through new experiences."





John Dos Passos Prize for Literature

In 1980, Longwood University founded the John Dos Passos Prize for Literature to honor one of the greatest American writers of the twentieth century by recognizing other writers in his name. The John Dos Passos Prize for literature is the oldest literary award given by a Virginia college or university, honoring this talented writer. The prize is presented annually to honor a writer whose work offers incisive, original commentary on American themes.

Each year, the John Dos Passos Prize for Literature is administered by a committee from the Department of English and Modern Languages; the chair of the committee also serves as the chair of the prize jury which includes the immediate past recipient and a distinguished critic, editor, or scholar. The prize jury awards the prize to an American creative writer who has produced a substantial body of significant publication that displays characteristics of John Dos Passos's writing: an intense and original exploration of specifically American themes, an experimental approach to form, and an interest in a wide range of human experiences.

Each year the writer visits the Longwood campus during the spring semester for a few days, during which they participate in at least one class in the Department of English and Modern Languages. At the conclusion of the

visit, there is a public "Reading + Interview" event open to the Longwood and Farmville community during which the author reads from their work before sitting down on stage to have a discussion about the prize and their writing. Questions for the interview portion are curated by Longwood students. In recent years, the prize jury has attended this event as well, providing additional opportunities for students and the community to interact with world class writers and editorial professionals.

Assistant Professor of Creative Writing and Chair of the Dos Passos Prize Committee and Jury, Brandon Haffner believes this unique opportunity also exposes students to a diversity of perspectives and lights a path to prospects they may not have previously explored. Longwood students have the opportunity to mingle with the writer and the Dos Passos prize jury after the presentation. Professor Haffner says, "You see certain students come out of their shells when reading the prize winner's work leading up to the event, and they get more and more excited to meet the author."

The John Dos Passos Prize for Literature is primarily funded by the Carson & Sharon Coulter Gibb '64 Endowment. During her time at Longwood, Sharon majored in English and recalls special programs Longwood required students to attend; however, they were not literary programs. When she learned Hollins College (now University) held a literary festival each spring, Sharon began attending the program. Upon the death of her husband, Sharon wanted to create a way to honor his memory at Longwood. Working with Franklin Grant of the University's Advancement Office, Sharon began supporting the John Dos Passos Prize for Literature in memory of her husband "and in envy of the Hollins girls."

ABOUT JOHN DOS PASSOS

John Dos Passos was born in 1896 in Chicago as the child of parents already married to other people. He lived for years with his mother in Europe, then returned to the United States to attend preparatory school. He discovered his interest in writing at Harvard, graduating in 1916.

After Harvard, Dos Passos joined the war effort as an ambulance driver in France; during this time he gathered the information for his first two novels, launching his writing career as he explored his views of postwar America.




Financial



This growth was primarily due to positive market performance from our investment portfolio, along with continued financial support from our donors. The Foundation also employed favorable administrative cost control measures, resulting in the ability to designate unspent monies toward an increase in its endowment reserves. The Foundation continues to be a reliable and generous source of funding for the University's students and programs. The Foundation ended 2021 with a significant increase in endowed and total net assets.


This market performance allowed our statement of activities to show a \$14.7 million positive change in net assets for the fiscal year ending December 31, 2021. Our statement of financial position shows \$116 million in total net assets, including \$105 million in the endowment for the benefit of student scholarships and programs.



Total benefits transferred by the Foundation to the University for Fiscal Year ending December 31, 2021 exceeded \$4.5 million, including \$2,215,385 for scholarships and \$2,288,572 for program and annual gifts. Administrative expenses to operate the Foundation were \$716,306, with excess funds from our administrative fee designated by our Board to increase our reserves.

Our donors continued to recognize the importance of the mission of our Foundation. Gifts raised by University Advancement and received by the Foundation for fiscal year ending December 31, 2021 totaled \$2,748,927. Amounts designated to be spent in the current year were transferred to Longwood University, and donations intended for the endowment were invested for the benefit of future spending for student scholarships and programs.

Additional revenue was earned from the sale of wetland mitigation banking credits created as a result of past environmental improvements at Hull Springs Farm. These proceeds are held by the Foundation until requested by the University for any costs related to operations and capital projects associated with the Baliles Environmental Center at the 600-acre farm in Westmoreland County.



*12/31/2020 is a six-month stub period. As of 12/31/2020 the Foundation changed its fiscal year to calendar year.

INVESTMENTS

For the fiscal year ending December 2021, the Foundation's investment portfolio, while incurring significant volatility, ended the year exceeding both its short term and 10-year average return benchmarks. Our endowed net assets, at December 31, 2021, have grown an impressive 44.4% since June 30, 2020 and 16.0% since December 31, 2020. This increase is after the Foundation's annual distribution of its scholarship and program funds based on a 4% spend rate and its annual administrative fee used to cover operating costs and any designated additions to reserves.

Our external investment managers continue to execute appropriate yield-related risk reward strategies in line with our goal of preservation of principal while seeking growth. The Foundation's investment strategy and asset risk management is implemented through the use of qualified investment managers and certain self-directed investment allocations. Monies invested are diversified and rebalanced in line with asset allocation and risk mitigation policies. Our goal is to achieve a 10-year average annual return of 8%+ to meet our scholarship and program awards and administrative funding needs while allowing the endowment to grow at a pace to potentially offset inflationary pressures from any tuition and room and board increases.

SPENDING AND DISTRIBUTIONS

The Foundation Board of Directors seeks to keep the total administrative fee charged to the endowment at less than 1.50% annually. This administrative fee is used to cover operating costs and provide for other designated uses. These operating costs primarily include staff compensation and benefits, reporting and administrative hardware and software, and outside professional fees for annual audit and regulatory filings. Along with those costs, the Foundation allocates funds to its reserves and provides certain contributions to fundraising and other University areas to include operating improvement projects.

To minimize the impact that short term market volatility and fluctuations have on endowment market values, the Foundation calculates its scholarship award spending based on a 12-quarter trailing average. The Foundation Board sets a spending rate (currently 4%) on that averaged balance to provide for funding scholarship commitments to the University's students and its programs.

CONCLUSION

The Foundation's financial results for fiscal year ending December 31, 2021, in addition to the latter half of 2020 provided for a significant increase in our endowment and ability to provide funding to the University. The Foundation continued its long history of strong stewardship to our devoted donors, meeting all regulatory reporting requirements and receiving annual audits of our Consolidated Financial Statements. The Foundation and University recognize the importance of growing our endowment as a way to make the educational experience affordable for students. We continue to seek growth of our endowment through sound investment policies, balanced spending, and the continued generosity of donors who are committed to providing support for our future citizen leaders.
